1. INTRODUCTION

- (i) The present legislation in Mauritius imposes at section 24(5) of the Medical Council Act an **“entry examination”** for Pre-registration Trainees before their enlistment for clinical training in hospitals of the Ministry of Health & QL. Section 24 of the Act is reproduced below, namely;

24.Pre-registration trainees

- (1) The Council may require a person applying for registration as a general practitioner under section 21 to undergo such training as it may determine before registering him.
- (2) The person applying for registration as a general practitioner who is required to undergo the training referred to in subsection (1) shall be registered as a pre-registration trainee.
- (3) Where a person who holds a diploma in medicine is required by the country, or the medical institution where he qualified, to complete a course of training, without which training he would not be eligible for registration as medical practitioner in that country, he may be registered as a pre-registration trainee until he has completed such course of training in an institution approved by the Council.
- (4) Every student in medicine who is undergoing pre-qualification training in Mauritius shall so inform the Council in writing, giving such particulars as the Council may require.
- (5) Entry examinations for pre- registration trainees shall be conducted by an independent body of international repute under the aegis of the Council before such trainees are enlisted by the Ministry.**

(Commencement 07 September 2016)

- ii) The Council has decided that this examination be called as Pre- Registration Entry Examination (PREE);
- iii) The Medical Council of Mauritius (MCM) is the authority mandated to conduct the Pre- Registration Entry Examination.
- iv) The PREE would be held twice yearly.
- v) The examination will be conducted in English language.
- vi) The examination will consist of one paper of 2½ hours duration.
- vii) There will be Multiple Choice Questions (MCQ) of single response type in the paper. Total number of questions will be 150.
- viii) The questions shall be of Final MBBS exit level. 75 questions will be from clinical specialities and the remaining 75 questions will be from applied basic sciences (pre & para clinical specialities).
- ix) There will be NO negative marking.
- x) An applicant shall be declared as having passed the examination only if he/she has obtained a minimum of 75 marks out of a total of 150 in the examination.

- xi) Results for eligible candidates who have **passed** will be declared to candidates and office of MCM. All other candidates would be required to collect their results from the Registrar's office personally.
- xii) The names of those applicants who pass the PREE will be communicated to the Ministry of Health & QL for their enrolment as Pre- registration Trainees in Regional Hospitals of the Ministry.
- xiii) There will be no restrictions on number of attempts that can be availed by an applicant.

2. INSTRUCTIONS FOR APPLICANTS

- a) Instructions in the booklet are liable to change based on decisions taken by the Government/Medical Council/Competent Authority from time to time. Applicants are required to refer to the latest bulletin or corrigendum that may be issued to incorporate these changes. Please refer to Medical Council of Mauritius website **medicalcouncilmu.org** for latest updates or corrigendum.
- b) Application forms can also be downloaded from Medical Council of Mauritius website.
- c) No queries will be entertained with regard to the eligibility and disclosures of results.
- d) Applicants are requested to carefully read the information bulletin before writing to office of the Medical Council of Mauritius for any information.
- e) Submission of incomplete application not in accordance with instructions will not be considered and the candidate will be declared ineligible. In such cases, the application fee will be forfeited.
- f) Applicants are required to submit all the requisite annexures with the application form; lack of relevant annexures shall lead to cancellation of application and the application fee will be forfeited.
- g) Applicants should possess a "diploma in medicine", i.e. MBBS or an equivalent qualification before the cut-off date of **May 04, 2018** and must submit proof of passing same. In absence of proof of possessing a "diploma in medicine" before the cut-off date of receipt of application, the application shall be treated as incomplete and fees will be forfeited and the candidature shall be cancelled.
- h) The foreign medical degrees (diploma in medicine) should be attested either by the Embassy of Mauritius in the country where the qualification has been awarded **or** should be "apostilled" by the appropriate authority of the foreign country.

- i) Applicants are advised to notify any change of address.
- j) Fees once paid will neither be carried forward to a future date nor be refunded under any circumstances. Fee should be paid by the applicant to the Medical Council of Mauritius.
- k) Applications of medical graduates producing false or fabricated records will not be considered and such applicants will be further debarred from appearing in the future examinations of Medical Council of Mauritius. Action as deemed appropriate by the Medical Council will be taken if false or fabricated records/information are submitted or any unfair means are used.
- l) **Appearance or success in the PREE does not confer any right upon a candidate for seeking registration with Medical Council of Mauritius.**
- m) Undertaking by applicant as per annexure "B" (Declaration by applicant) has to be submitted with application form.
- n) The Admit Card is not transferable to any other person. Impersonation is a punishable offence under law. **CANDIDATES ARE REQUIRED TO BRING THEIR NATIONAL IDENTITY CARD OR PASSPORT ALONG WITH THE ADMIT CARD FOR ENTRY TO THE EXAMINATION CENTRE.** The Medical Council of Mauritius reserves its absolute right to verify the identity of the applicant/candidates.
- o) Candidates are required to strictly adhere to the reporting time as indicated in Admit Card/Information Bulletin. Exam centre gates shall be closed at **9.15 am** sharp. Early exit of candidates is not permissible under any circumstances.
- p) Unfair means: Medical Council of Mauritius reserves its absolute right to take such action as it deems appropriate against candidates found using unfair means.

NOTE: *Unfair means includes canvassing for support of a candidate with examiners of PREE/Medical Council Office/any other functionary/use of electronic gadgets as mobile phones during exam/impersonation/use of study aids such as books/notes etc. during exam/influencing any functionary of exam system/any other act intended to breach the sanctity of examination process.*
- q) Candidates are advised to enter a correct valid 8-digit mobile number in their application form.
- r) Jurisdiction for all disputes shall be exclusively at competent Court in Mauritius.

3. ELIGIBILITY CRITERIA

The applicant must meet/fulfill the following criteria:

- a) He/She is a citizen of Mauritius or he/she is a non- citizen holding a residence permit under section 5(1)(c) of the Immigration Act.
- b) The candidate should possess a "diploma in medicine" or an equivalent qualification, awarded by a recognized/listed medical institution under the Medical Council Act of Mauritius.
- c) Cut-off date for obtaining the "diploma in medicine" (or equivalent qualification) shall be before the conduct of exam i.e. on or before **May 04, 2018**. It is mandatory to provide proof/documentary evidence in support of the candidate having passed final examination for such a primary medical qualification before the cut-off date. In the event of the date of issue of result/proof of primary medical qualification being after the prescribed cut-off date, the application form shall be rejected and candidate declared as ineligible.

4. EXAMINATION CENTRE

- a) The exam shall be held on **May 19, 2018** by the Mauritius Examination Syndicate.
- b) Timing of the exam is as from 9.30 am to 12.00 pm.
- c) Reporting Time for candidate is 9.00 am.
- d) The exact venue for the examination shall be notified in the Admit Card.
- e) All candidates are required to bring their National Identity Card or passport as proof of identity at the exam centre. Candidates shall not be allowed to appear in the examination if they are unable to produce their original National Identity Card or their original passport.

5. PAYMENT OF FEES

Candidates are required to submit the following fees:

- a) Examination Fee – Rs 1, 000/-
- b) The fee is payable to the Office of the Registrar, Medical Council of Mauritius either by cheque or by cash.

Kindly Note: -

Candidates absent from the examination will forfeit their examination fee. Candidates are advised to read the rules and regulation carefully and satisfy the terms and conditions for fulfilment of eligibility criteria. Fees shall neither be refunded nor carried forward if the application for PREE is rejected/candidature is found to be ineligible or candidate does not appear in examination.

6. VERIFICATION OF DOCUMENTS/CREDENTIALS

Applicants are required to submit copies of

- a) Proof of Date of Birth.
- b) National Identity Card.
- c) SC/GCE (Ordinary Level) and HSC/GCE (Advanced Level) examination certificate or equivalent.
- d) "Diploma in medicine" or an equivalent certificate e.g. MBBS. The degree/diploma should be attested either by the Embassy of Mauritius in the country where the "diploma in medicine" has been awarded or should be "apostilled" by the appropriate authority in the foreign country.
- e) Translated copies (in English) duly attested to be produced if the certificates are in a language other than English or French.
- f) Ex-candidates who would re-appear should submit copy of their latest PREE fail certificate/result. (*not applicable presently*)

NOTE

- *APPLICANTS TO ENSURE THAT ATTESTED COPIES OF ALL THE CERTIFICATES MENTIONED ABOVE ARE SUBMITTED ALONG WITH THEIR APPLICATION FORM.*
- *FAILURE TO SUBMIT THE SAME WITH APPLICATION FORM SHALL LEAD TO THE APPLICATION FORM BEING TREATED AS INCOMPLETE & FEES FORFEITED.*
- *NO INTERIM CORRESPONDENCE IN THIS REGARD SHALL BE ENTERTAINED.*

7. INSTRUCTIONS FOR FILLING THE APPLICATION FORM

- a) Write in capital letters only and tick the required information in the boxes wherever provided.
- b) Please note that your name should be exactly the same as in your SC/GCE (Ordinary Level) and HSC/GCE (Advanced Level) or equivalent examination certificate, and in the "diploma in medicine" (or equivalent) certificate.
- c) 2 copies of recent passport size **colour** photograph of the applicant are required
- d) The photographs **must bear the name and signature of the applicant.**
- e) Application form must be signed by the applicant on both pages. Application form without signature will not be considered and shall be rejected.
- f) The applicant is required to give his/her contact postal address in capital letters.
- g) Application form must be filled by candidate in his/her own handwriting.

8. ADMIT CARDS

- a) Admit Card will be issued to all eligible applicants whose complete application forms have been received by Medical Council of Mauritius on or before the last date of receiving the application form.
- b) The applicant should carefully examine the Admit Card and ensure that all the entries therein are correct. In case of any discrepancy, same shall be brought to the notice of Medical Council of Mauritius.
- c) Candidates are required to bring the following as proof of identity to Examination Centre for PREE:-
 - 1. Original National Identity Card/or passport (Mandatory for all candidates).
 - 2. Admit Card issued by Medical Council of Mauritius.

Entry to the PREE centre shall **not** be allowed without the above identity proof.

- d) All applicants shall carefully preserve the Admit Card till the registration process is complete.
- e) A plea that the applicant failed to receive the information for appearing in the PREE will not be accepted as a ground for the refund of fee or any other claim.
- f) **Medical Council of Mauritius reserves the absolute right to withdraw the permission, if any, granted inadvertently to any applicant who is not eligible to appear in the PREE even though an Admit Card has been issued or name displayed on the website/notice board of Medical Council of Mauritius.**

9. SUBMISSION OF APPLICATION FORM

10. DECLARATION OF RESULT OF PRE- REGISTRATION ENTRY EXAMINATION

- a) The Result of the Pre- Registration Entry Examination will be declared by the Medical Council and affixed on the Notice Board of the Council. All successful candidates will be informed.
- b) Result letters shall be sent to unsuccessful candidates by post.
- c) Applicants are advised to enter their postal address correctly.**
- d) There is no provision for re-evaluation/re-totalling.**
- e) Request for issuance of duplicate copy may be entertained under certain circumstances**

11. DECLARATION BY THE APPLICANT

The applicant **MUST** sign the application form. "Application form" without signature or with different signature at two places will be treated as incomplete and will be rejected. **Application form not filled by candidate/ not signed by candidates will be rejected.**

PRE- REGISTRATION ENTRY EXAMINATION

This is to inform the public in general that section 24 (5) of the present Medical Council Act provides for an examination prior to enrolling a person as a Pre- Registration Trainee. (Please refer to Medical Council of Mauritius website medicalcouncilmu.org)

Consequently, any person possessing a “diploma in medicine” or an equivalent qualification (for e.g. MBBS) and who wishes to be enrolled in a Regional Hospital as Pre- Registration Trainee has to appear in a “Pre- Registration Entry Examination” which will be conducted by the Medical Council of Mauritius.

The “Pre- Registration Entry Examination” will be conducted on **May 19, 2018**. The venue and time will be communicated to all eligible candidates in due course. There shall be one paper of multiple choice questions. The language of the test shall be in English. The paper will be of 2½ hours duration. An applicant shall be declared as having passed the examination only if he has obtained a minimum of 50 % marks.

No candidate shall be allowed to appear in the examination unless:

- i. He / She is a citizen of Mauritius or he/she is a non- citizen holding a residence permit under section 5(1)(c) of the Immigration Act.
- ii. He possesses a “diploma in Medicine” or equivalent qualification awarded by a recognized medical institution listed in the Medical Council (Medical Institutions) Regulation 2004 as amended (to consult Medical Council of Mauritius website at address: medicalcouncilmu.org)

Last date for Receipt of Application Forms is **May 04, 2018**.
