Call for Applications - 5th Cohort of the Kofi Annan Fellowship in Global Health Leadership Programme

Please find attached, for your consideration, copy of a memorandum dated 4 December 2024 from our Mission in Addis Abba, transmitting a Note (Ref: AU/CDC/PHI/NV/6446.24) dated 29 November 2024 from the Africa Centres for Disease Control and Prevention (Africa CDC), inviting senior public health professionals from African Union Member States to apply for the 5th Cohort of the Kofi Annan Fellowship in Global Health Leadership Programme, which is scheduled to commence in June 2025.

- 2. The Kofi Annan Fellowship in Global Health Leadership Programme was launched on 25 May 2020 in view to support aspiring public health leaders in acquiring advanced skills and competencies to strategize, manage and lead public health programmes. Successful applicants are leaders who want to acquire advanced skills in leading impactful health initiatives, employing health diplomacy, as well as enhance their ability to develop bold, strategic and achievable goals to propel Africa towards achieving Agenda 2063.
- 3. The eligibility criteria for the fellowship are as follows:
 - · be citizens of an African Union Member State;
 - possess a postgraduate degree in a relevant field in public health;
 - have 10 years of professional experience after gaining a Master's degree in any field of
 public health, including but not limited to Sexual and Reproductive health, one health,
 human medicine, finance, health economics, health policy, animal health, or
 environmental health;
 - be in full-time employment in any area of public health, in public or private institution in Africa; and
 - have a good track record or be able to demonstrate the potential for effective public health leadership where they can positively impact the public health outcomes of populations in Africa.
- 4. All applications must be submitted online together with the following supporting documents:
 - A support letter from the current employer to confirm employment, guaranteeing that the
 candidate will be allowed enough time to participate in the Fellowship programme and
 to attend the full eight weeks of institutional residential experience;
 - Letters of recommendation from two reputable professional referees;
 - A leadership challenge project proposal (maximum 400 words) that outlines a potential leadership challenge project they will implement which is feasible to complete with in the 12 month of the fellowship. The proposal should include a title, brief description of

the challenge (the what, the who is affected, and the why), a proposed strategy for a solution, and the expected outcome; and

 A personal statement (maximum 400 words) providing evidence of the candidate's commitment to public health in Africa detailing the following:

a) Their leadership experience and professional attainment;

b) Their vision of, and the future impact of effective public health leadership in Africa;

c) How they would champion public health initiatives in Africa.

- 5. The closing date for applications is <u>30 December 2024</u> and the link for submission of completed applications is https://impact.africa-edc.org/form/kaf-5 (Note that incomplete applications and applications sent over email will not be considered.)
- 6. In this context, it would be appreciated if the call for application could be kindly disseminated to eligible health professionals who meet the criteria as spelled out at paragraph three above.

The Africa Centres for Disease Control and Prevention - Africa CDC presents its compliments to the Permanent Mission to the African Union and has the honor to refer to the Decision Assembly/AU/Dec.554 (XXIV) adopted at the 24th Ordinary Session of the Assembly held in Addis Ababa, Ethiopia in January 2015, which established the Africa Centres for Disease Control and Prevention (Africa CDC), and approved the Africa CDC Statute; and wish to refer to Article 3(f) which emphasizes the harmonization of disease control and prevention policies, and the surveillance systems in the African Union Member States with a mission to strengthen Africa's public health institutions' capacities and capabilities.

The Kofi Annan Fellowship In Global Health Leadership Programme launched on May 25th, 2020, seeks to support aspirational public health leaders (Fellows), in acquiring advanced skills and competencies to strategize, manage and lead public health programmes that will positively transform public health in Africa. The aspiration is for Kofi Annan Public Health Fellows to emulate the exemplary leadership qualities of Secretary Kofi Annan and go on to contribute to and lead the implementation of a new Public Health Order for Africa, and in turn, develop the next generation of public health leaders.

As part of this initiative, Africa CDC has graduated its first three cohorts and is currently training the fourth cohort. The fellowship program lasts 12 months and employs a hybrid methodology that includes webinars, lectures, a leadership challenge project, and four weeks of in person residential.

On November 15, 2024, the program opened a call for applications for the fifth cohort. This application period will remain open for six weeks and will close on December 30,2024. In this regard, Africa CDC encourages all member states to share this call for applications with qualified candidates within their health institutions. As we reflect on the remarkable progress of the Kofi Annan Fellowship in Global Health



Fellowship eligibility criteria

Applicants for the Fellowship must:

- be citizens of an African Union Member State;
- possess a postgraduate degree in a relevant field in public health;
- have 10 years of professional experience after gaining a masters degree in any field of public health, including but not limited to Sexual and Reproductive health, one health, human medicine, finance, health economics, health policy, animal health, or environmental health
- be in full-time employment in any area of public health, in public or private institution in Africa;
- have a good track record or be able to demonstrate the potential for effective public health leadership where they can positively impact the public health outcomes of populations in Africa.

Fellowship selection

Fellowship Selection Selection to the Fellowship will be by an independent committee comprising of experts from the African Union Commission, Africa CDC, and their global partners. The selection process will emphasize an equal opportunity approach to secure the representation of women and underrepresented groups.

Financing

Africa CDC will provide all learning and development materials and meet all costs associated with the fellowship, including travel, daily allowance and insurance during the residential placements. Fellows will be supported to ensure that they have the relevant software for online learning.

How to apply

All applications must be submitted using the online application form. Incomplete applications will not be considered. All applicants must provide the following required information:

- A support latter from the current employer to confirm employment, gueranteeing that the candidate will be allowed enough time to participate in the Fellowship programme and to attend the full eight-weeks of institutional residential experience.
- Letters of recommendation from two reputable professional referens

Kofi Atta Annan, the seventh Secretary-General of the United Nations, Nobel Peace Prize Laureate, and founding chair of the Kofi Annan Foundation, exemplified visionary and principled leadership over the course of his life and career. Of his numerous accomplishments was the establishment of the Global Fund for AIDS, Tuberculosis, and Malaria (The Global Fund), which changed the approach to preventing and managing infectious diseases and the practice of public health globally.

Visionary and principled leadership is critical for Africa to implement a new public health order that will enhance the timely detection and effective response to public health threats, and to ensure Africa has a healthy and productive population. It is also critical for mitigating the economic and social effects of these health threats while contributing to sustainable achievement of Africa's Agenda 2063 and the Sustainable Development Goals. The African Union Commission launched the Africa Centres for Disease Control and Prevention (Africa CDC) Kofi Annan Global Health Leadership program on 25 May 2020 in partnership with the Kofi Annan Foundation, following its approval by the Governing Board of Africa CDC in March 2018. The Kofi Annan Global Health Leadership program encompass the Kofi Annan Fellowship in Global Health Leadership, the Kofi Annan Scholars program and the Kofi Annan Policy forum.
