

Government Notice No. 15 of 2026

THE MEDICAL COUNCIL ACT

Regulations made by the Minister, after consultation with the Medical Council of Mauritius, under section 42 of the Medical Council Act

- 1.** These regulations may be cited as the Medical Council (Medical Institutions) (Amendment) Regulations 2026.
- 2.** In these regulations –
“principal regulations” means the Medical Council (Medical Institutions) Regulations 2016.
