**NOTICE OF ELECTION OF
EIGHT (8) MEMBERS OF THE
PHARMACY COUNCIL OF MAURITIUS**

Notice is hereby given to all registered pharmacists that the election of eight (8) members of the Pharmacy Council of Mauritius, comprising of three (3) members from the public sector; and five (5) members from the private sector, will be conducted by the Office of the Electoral Commissioner on **Saturday the twenty-third (23rd) day of April, 2022**; and that the Returning Officer will receive the nomination of candidates for the said election on **Tuesday the fifth (5th) day of April, 2022**, next ensuing, between the hours of **10 a.m. and 2 p.m.** at the Office of the Electoral Commissioner, Level 9, Max City Building, Corner Remy Ollier and Louis Pasteur Streets, Port Louis.

Forms of nomination paper may be obtained **either** from the Registrar, Pharmacy Council of Mauritius, Room No. 1023, 10th Floor, Emmanuel Anquetil Building, Port Louis **or** from the Health Director, Queen Elizabeth Hospital, Crève Coeur, Rodrigues, between the hours of 9 a.m. and 3 p.m. on working days (excluding Saturdays).

Every nomination paper must be supported in writing, by not less than **five (5)** pharmacists and be delivered to the Returning Officer between the said hours of 10 a.m. and 2 p.m. on **Tuesday the fifth (5th) day of April, 2022**.

Every nomination paper shall specify the name, address and date of registration of the candidate and also contain a declaration by the candidate that on nomination day:-

- (a) he/she is a citizen of Mauritius;
- (b) he/she is a pharmacist having not less than 7 years' experience as pharmacist in Mauritius; and
- (c) (i) he/she is not subject to any preliminary investigation under section 27;
- (ii) no disciplinary proceedings are being held against him under section 28; and
